1. Cambridge Gazette: グローバル戦略編第 21 号

世界的な国際政治学者であるジョセフ・ナイ本校教授による新著(The Future of Power)を読んでいる(次の2を参照されたい)。筆者が、ナイ教授から同書の執筆に関しお話を伺ったのは昨年3月。その後、ナイ教授はわずかな期間—英国のオックスフォード大学に引き篭もって集中的に執筆された時期—を除き、極めて多忙な日々を過ごされていた。すなわち様々な研究会に参加され、また世界各国を廻られていたのだ。それを知っているだけに、今300ページ(索引を含む)の本を眼前にして、ナイ教授の知性だけでなく、教授の探究心と努力、更には或る意味での執念を肌で感じている。

奇異な言い方になるが、この本の 300 ページは単なる 300 ページではない。国際政治経済社会に関する様々な情報が盛り込まれている上に、品格を保ちつつも簡明に表現された教授の主張が各ページに溢れている。当然のこととして、これまで教授の洞察力溢れる主張がそのまま賞賛と賛同とをもって識者から広く受け容れられた訳ではない。それを指し示すかのように 236 ページの本文に対し、前書きが 18 ページ、更には巻末に総計 595 個の注釈が 46 ページにわたって付けられている。同書を著すにあたり、同書の現実社会の中での位置付けを、また誤解を招かぬよう同書を如何に読むべきかを、教授は丁寧に記されたのだと筆者は理解している。そして注釈のひとつひとつを読むと、研究者や実践家から指摘されたこれまでの建設的批判を謙虚に受け止め、それらに対して証拠立てて丁寧に反論しているナイ教授の真摯な姿勢が感じ取れる。浅学菲才の筆者ではあるが、ひとりの人間として、ナイ教授からこの謙虚で真摯な態度を学んでみたい。
