


Extended Continental Shelf







state


Article 56

 Coastal states shall have due regard for the rights and duties of other states in the EEZ

"Due regard" ≠ substantive right

"other internationally lawful uses of the sea"

- Article 58(1) *facilitates* rather than limits military activities
- UNCLOS: Freedoms of movement and communication included activities that were ancillary to the exercise of freedoms
 - Military exercises and activities
 - Space-related missions
 - Intelligence, law enforcement, national security


