1. Cambridge Gazette: グローバル戦略編第 14 号

周知の通り中印両国の近年における経済的台頭は目覚しい。と同時に両国における軍拡のペースも国際関係を学ぶ人間にとっては無視できないものとなっている。従って6月4日から開催される第9回シャングリラ・ダイアログでの関係各国の態度が注目される。こうした理由から小誌今月号もワシントンに在るシンクタンクでの会合を記した(2の外交・安全保障の部分を参照)。中印両国の台頭にともない米国の専門家はその世界戦略の練り直しを絶えず迫られている状況だ。このために筆者の友人も頻繁に北京とニューデリーに飛んで現地の専門家との直接対話を行っている。こうしたなか我が国は如何なる形で、すなわち米国との緊密な関係を保ちつつどのような形で中印両国との関係を強化していくのか。この複雑な問題を考えるには、異なる分野の専門家が叡智を合わせ、外交政策・企業戦略に関する複数のオプションを練り上げていくプロセスが不可欠であろう。

本学を中心とした国際的・学際的な会合に参加すると日本人の参加者数の少なさを痛感する。小誌前号で紹介した Asia Vision 21 (21 世紀のアジアを考える討論会)では、参議院議員の林芳正氏や日本銀行の堀井昭成氏、更には研究者では政策研究大学院大学の黒川清教授や東京大学の伊藤隆敏教授等が「一騎当千」の国際人として大活躍していらっしゃる。とは言うものの、当然のことながら「衆寡敵せず」の感が拭いきれない。この意味で1人でも多くの優秀な若人が国際人として成長し、広い視野を具えてくれることを願っているのは筆者独りではあるまい。
